- Hwy. 16, Exit for Purdy/Key Center/Shelton, Hwy 302 W.
- Travel into Purdy, turn west at the light onto Gig Harbor - Longbranch Hwy.
- Cross the Wauna Bridge, travel 5.1 miles
- Turn **RIGHT** onto Hwy 302 W, Elgin Clifton Rd KPN, toward Shelton/Allyn (There are clearly marked signs leading to HYW 302 W)
- Travel 1.2 miles, turn **RIGHT** onto 150<sup>th</sup>
- Travel 0.1 miles (end of chain link fence) turn **LEFT** onto 1<sup>st</sup> road, Rocky Creek Conservation Area.
- Follow road approximately 0.8 mile through park, through PackLeader's green farm gate.
